- VII. OLD BUSINESS (School Security Updates) Mills & Mobley
 - **A.** Security & Mental Health Plans: Update: SOS opted into Duval County Public Schools Mental Health Plan for the 2021-2022 school year.
 - **B.** BTAT (Behavior Threat Assessment Team) & Active Assailant & Fire Drills Monthly: All reports are up to date. SOS has been assigned a new JSO officer to be the JSO liaison for the school's security program; the former officer, James Anderson received a promotion. The BTAT met with the two new officers. Partnership with Right Path is current. Two students had to be referred to Right Path per request of the parents.

C. SOS 2021 Contract Renewal Information -

The contract renewal for SOS was approved for three years, beginning July 1, 2021, ending June 30, 2024. Once the contract is signed, each board member will receive a copy.

Mr. Ansley suggested setting up a board workshop to discuss how SOS Board members could be more engaging with the school and to bring in more resources and partnerships. Suggestive meeting dates will be sent out for board approval to discuss pertinent issues.

VIII. NEW BUSINESS - Ms. Mills

- **A.** Charter School Spring Site Visit 5/11/21 SOS was in full compliance with the exception in the area of ESE / EOL. Principal Mills is currently working with the staff to rectify this situation.
- **B.** First initial sales Tax Funding received in March for January 2021. School received over \$7,000 from the sales tax funding.

IX. DIRECTOR'S/PRINCIPAL'S REPORT – Ms. Genell Mills

A. C.A.R.E.S. Grant – federal government is allocating more money to schools for COVID relief. A check is expected to be received from the C.A.R.E.S. Grant.

X. CONSULTANT'S REPORT – Dr. James Young (Turnaround Solutions Inc.)

Dr. Young have not been visiting schools however he stays in contact with SOS as a virtual consultant.

XI. ASSISTANT PRINCIPAL CURRICULUM & INSTRUCTION REPORT – Ms. Shirlene Scott

- **A.** On-Line Curriculum Implemented Still continuing with the same curriculum no change.
- B. Achieve 3000 and I-Ready Math End-of-Year: Update

Students have completed third level-set (Achieve 3000), and diagnostic (I-Ready)

• Overall 6th grade:

Improvements in Reading with in a 20% increase from approaching to meets. Math stayed with the same with an 10% move from tier 2 to tier 1.

• Overall 7th grade:

Significant increase in both reading and math. Reading – 30% increase; Math- 20% increase

• Overall 8th grade:

Reading- 10% increase; Math-slight decrease by 5%

Testing

- Testing goal- 95% or higher
- ELA Writing- tested 100% of our student population
 - FSA reading has been completed with the exception of make-ups.
 - FSA math and NGSSS Science is being tested this week.
 - Algebra 1 and Civics EOC will be tested next week.

D. 2020-21 SIP GOALS & Continuing Improvement

SOS is on target with the SIP (School Improvement Plan) goals. The continuous improvement goal is to get students reading on their grade level.

SOS was selected as a Tax Watch School. Two schools in Duval County were chosen to receive the FL TaxWatch Award: Violet Stoval, Ft. Caroline Elementary and Genell Mills, SOS Academy Middle. Principal Mills will be traveling to Orlando in June to receive this award.

Florida Tax Watch partnered with FL Prepaid College Foundation and Sun Trust Bank to offer a deserving student a free 2-year college scholarship selected by the principal. Que'ni Crawford, 8th grade Valedictorian from SOS Academy was selected to receive this scholarship.

- **A.** School-wide Discipline, Transportation, Health & Welfare Reports
 No discipline issues to report. Two students were referred to Right Path due to parents seeking help for their child.
- B. 35 sixth graders; 52 seventh graders and 51 eighth graders = Current Total of 135
 Our Target is 180 to 200

Principal Mills said student count decreased from 138 to 135 due to students transferring to other schools at the end of the year.
